For any documents over 100 pages, a fees notice will be issued and that fee will be for the total number of pages that require printing.

Charges may also be made for information provided under this scheme where they are legally authorised, they are in all the circumstances, including the general principles of the right of access to information held by public authorities, justified and are in accordance with a published schedule or schedules of fees which is readily available to the public.
